

Lifetime RESIDENTIAL LIMITED WARRANTY

Dirt Devil® branded central vacuums are manufactured under exclusive license from Royal Appliance Manufacturing Company by H-P Products, Inc., located at 512 West Gorgas Street, Louisville Ohio, 44641. The following is the exclusive limited warranty provided by H-P Products, Inc.

All permanently installed components of the Dirt Devil® Built-In Central Vacuum System are warranted to be free from defects in material and workmanship under normal use and care as long as the original consumer purchaser owns the home of original installation or until the power unit is removed from its original installation, whichever occurs first. Motor brushes are covered by a **three (3) year** warranty.

In the event of a defect in permanently installed components of the Dirt Devil® System, an authorized dealer should be contacted. Repaired or replacement parts (at our option) will be provided to you for any items under warranty. Filter cartridges are not covered under warranty and should be replaced yearly.

Attachments. All Dirt Devil® cleaning attachments are warranted to be free from defects in material and workmanship under normal use and care for **three** (3) years from original date of consumer purchase – see electric powerhead manual for specific warranty. In the event of a defect in a Dirt Devil® attachment, a repaired or replacement part (at our option) will be provided to you for any item(s) under warranty. There is no warranty for consumable items such as light bulbs, belts and beater brushes.

<u>Limitations of Warranty.</u> The Lifetime Warranty begins on the date of the original purchase of the unit. This warranty specifically excludes and there is no warranty on original or replacement filters cartridges and further excludes any damage due to shipping and handling or damage due to installation, or faulty installation.

In order to obtain coverage under this warranty, an owner must provide proof of purchase or have registered the Dirt Devil® Central Vacuum Power Unit at 1-800-822-9277, online at *www.cvacregistration.com*, or by completing and mailing the warranty registration card. In addition, to recover under this warranty, an owner must have provided normal care and maintenance for the unit including, but not limited to, replacing the filter cartridge as needed and recommended by the Instruction Manual.

THIS WARRANTY IS THE SOLE AND EXCLUSIVE WARRANTY FOR THIS PRODUCT. ALL OTHER WARRANTIES INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY OR WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE ARE SPECIFICALLY EXCLUDED.
